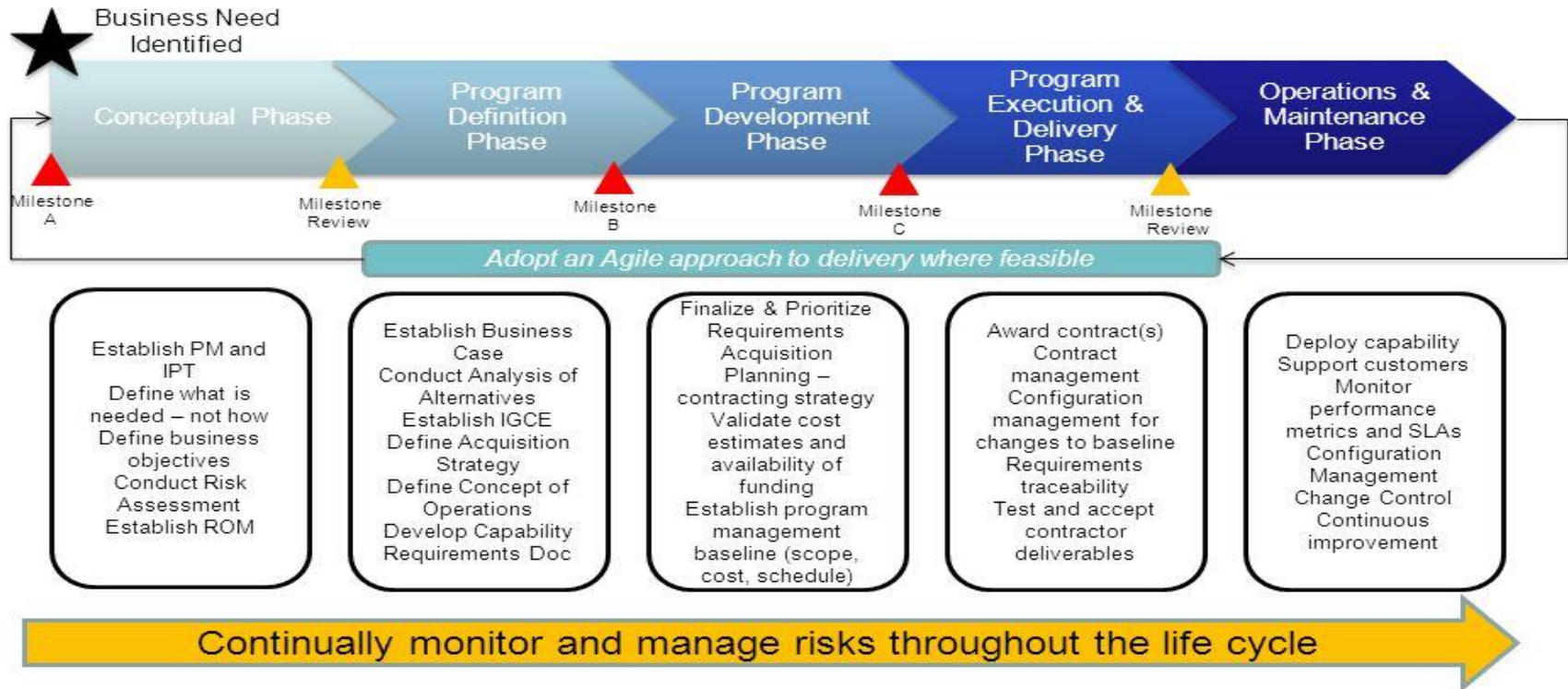


LTMC Full Life Cycle Acquisitions Approach
